In the event there are no nominees or an insufficient number of nominees for each elective office and a petition for an election is not filed within the time period prescribed by law, an appointment to each elective office shall be made pursuant to Elections Code Sec. 10515.

## LEGAL UPDATE

**RE:** Update on COVID-19 Orders

---

On June 11, 2021, Governor Newsom issued Executive Orders N-07-21 and N-08-21. N-07-21 rescinded N-33-20, the stay-at-home order, and N-60-20, which provided for the “Blueprint for a Safer Economy” reopening plan. N-08-21 made a wide range of changes to prior Executive Orders issued under the Governor’s emergency powers. All public agencies that are presently relying on exceptions to statutory requirements made by the Governor during the COVID-19 pandemic under his emergency powers should review this order to determine whether those exceptions still apply. This update summarizes some key provisions of N-08-21.

### Brown Act

Under N-29-20, ¶3, which superseded N-25-20, ¶11, agencies have been permitted to conduct meetings under the Brown Act by teleconference subject to relaxed procedures. N-08-21, ¶42 provides that such relaxed procedures may be used through September 30, 2021. After that date, the usual Brown Act rules on remote meetings will apply, including the requirements that all directors participate from locations that are listed in the meeting notice and open to members of the public, and that at least a quorum of the agency’s board be present in the agency’s jurisdiction. Please note that, in the meantime, agencies should still ensure that they comply with Government Code section 54953(b)(2), which provides, “All votes taken during a teleconferenced meeting shall be by rollcall.”

Under N-35-20, ¶2, the governing body of an agency has been permitted to “receive updates ... relevant to the declared emergency ... from federal, state, and local officials, and may ask questions of those federal, state, and local officials, in order for members of the legislative body to stay apprised of emergency operations and the impact of the emergency on their constituents.” N-08-21, ¶44 discontinues this exception as of September 30, 2021.

### Retired Annuitants

N-25-20, ¶7, made applicable to local agencies by N-35-20, ¶3, suspended working hours limitations of retired annuitants. N-08-21, ¶44 reinstates those limitations as of September 30, 2021.

**Government Claims Act**

N-35-20, ¶11 and N-71-20, ¶6 provide a total of 120 days' extension of deadlines to file claims under the Government Claims Act. N-08-21, ¶7 provides that claims accruing before June 30, 2021 continue to be subject to that extension.

**Water Service Shutoffs**

N-42-20 imposed certain limitations on shutting off water service for non-payment, including water service to "essential businesses" meeting certain criteria. Whether that order applies to irrigation deliveries is not clear, as we indicated in our legal update dated April 6, 2020. N-08-21, ¶47 provides that such restrictions will end on September 30, 2021.

**CEQA**

N-54-20, ¶8 and N-80-20, ¶6 suspended certain "public filing, posting, notice, and public access requirements" of CEQA, including the requirement of posting, with the county clerk, Notices of Preparation of an Environmental Impact Report, Notices of Determination, Notices of Exemption, and Notices of Intent to Adopt a Negative Declaration. N-54-20, ¶9 suspended the "timeframes" provided in CEQA for a California Native American Tribe to request consultation on cultural resources issues under Public Resources Code section 21080.3.1 and for the lead agency to initiate that consultation under 21082.3. N-08-21, ¶50 provides that both of these exceptions will end on September 30, 2021. Timelines for tribal consultation that extend beyond September 30 are extended so long as the triggering event occurred on or before September 30.
