Dear Ms. James & Mr. Reyes:

Based on its current forecast, the District requests consideration for the Rescheduling of an estimated 1,498 AF of 2021 DMC stored non-project supply generated through the DMC Pump-In Program - Contract No. 18-WC-20-5248, 4,338 AF of stored non-project water stored under the District's Warren Act Contract No. 21-WC-20-5818, and 13,706 AF of water Exchanged/Stored under the North Valley Regional Recycled Water Program. These various supply types total 19,542 AF of supply, all of which will be stored in San Luis Reservoir.

In making this request, the District agrees to abide by the January 31, 2022 Guidelines for Rescheduling, as well as the March 17, 2021 Business Practice Guideline for Rescheduled Central Valley Project Water.

## **MEMORANDUM**

SUBJECT FEBRUARY OPERATIONS UPDATE

DATE: FEBRUARY 4, 2022

## **Project Operations**

- Declining Delta inflow forced Jones Pumping to reduce from capacity pumping last
  week to the current 2-unit operation or 1,800 cfs. Banks pumping is also operating at
  minimum capacity to meet an increased Delta outflow requirement that went into effect
  on February 1 per D-1641. Total exports will remain low until the next significant storm
  system arrives which does not show in the 7-day forecast.
- The current Delta outflow requirement for February is 11,400 cfs; an increase of 6,900 cfs from the January requirement. Due to persistent dry conditions, the Delta outflow requirement can only be met with the release of stored water from upstream reservoirs. Absent additional runoff this month to help meet the outflow requirement, an additional 384 TAF of stored water may need to be released to meet the February requirement.
- Reclamation's latest estimate of the accounting balance under the Coordinated
  Operations Agreement (COA) is about 300 TAF in favor of the CVP. Or oville recently
  increased its releases to help the CVP meet its share of the Delta outflow requirement
  and pay down the COA debt to the CVP.
- Accumulated precipitation in the Sacramento Valley finished January at 15% of average. Persistent dry conditions have caused the annual precipitation to slip from 160% of average in early January to 115% today.
- Shasta storage is about 1.62 MAF an increase of about 280 TAF from a month ago. The current storage is trending 35 TAF below Reclamation's latest 50% exceedance which shows the reservoir refilling to 3.8 MAF by the end of May. Reclamation anticipates that January conditions were dry enough to trigger a Shasta Critical Year in the DWR 90% exceedance runoff forecast that will be posted next week.
- Folsom storage is 533 TAF which is near its maximum allowable flood control limit. Releases are holding at 2,000 cubic feet per second (cfs) to meet the increased Delta outflow requirement. Dry conditions during January eroded the snowpack from 155% of average early in the month to the current 90% of average.
- CVP demands for January were 19 TAF which was 25% of the 15-year average.

## 2021-22 San Luis Reservoir Operations


The CVP's share of the San Luis Reservoir (SLR) is about 317 TAF – an increase of 212 TAF during January.

The attached SLR projection chart under 90% exceedance conditions shows CVP SLR refilling to 300-400 TAF by late March before drawing down. Currently, an estimated 230 TAF of non-project water is stored in CVP SLR. As such, only 87 TAF of Project water is currently available to meet 2022 allocations. Reclamation's 90% exceedance forecast assumes there is enough water in the forecast to meet minimum allocations to senior water rights contractors. Due to many significant operational uncertainties, Reclamation's initial allocation this month is expected to be 75% for Exchange Contractors and refuges, 50% to urban contractors, and 0% for Ag Service contractors.

The attached SLR projection chart under 50% exceedance conditions shows CVP SLR refilling to more than 500 TAF by the end of March. Although conditions look dry for the next 7-10 days, if conditions don't deteriorate too far from Reclamation's 50% exceedance forecast, the allocation for Exchange Contractors and refuges would increase to 100% while urban and Ag Service contractors could receive 55% and 5%, respectively. However, the possible allocation increases may not occur until later this spring when regulatory and hydrologic uncertainties diminish.

## WATER TRANSFER AGREEMENT 2021 WATER YEAR

THIS AGREEMENT is made and entered into effective the 9th day of February 2022, by and between DEL PUERTO WATER DISTRICT, hereinafter referred to as "Del Puerto", and ARVIN-EDISON WATER STORAGE DISTRICT, hereinafter referred to as "Arvin-Edison", collectively referred to as "Parties".

## WITNESSETH:

WHEREAS, Arvin-Edison has the right to receive agricultural water from the Friant Division Central Valley Project ("CVP") under Water Service Contract No. 14-06-200-229A, and is willing to transfer a portion of its 2021 CVP agricultural supply to Del Puerto; and

WHEREAS, Del Puerto has the right to receive agricultural water from the CVP under Water Service Contract No. 14-06-200-922-LTR1-P; and

WHEREAS, Parties have an exchange program involving multiyear transfers between each district for an up to 15,000 acre-feet (AF) per year approval through the 2022 Contract Year (EA-17-031); and

WHEREAS, Del Puerto has delivered water to Arvin-Edison in 2017, 2018 and 2019 and this action provides for the return of such water under mutually agreement.

NOW, THEREFORE, subject to Bureau acknowledgement, the Parties hereto agree as follows:

- 1. Arvin-Edison does hereby transfer and authorize the Bureau to deliver to Del Puerto up to 500 AF of 2021 CVP Water available to Arvin-Edison ("Transferred Water").
- 2. The Transferred Water shall be scheduled for delivery by Del Puerto from San Luis Reservoir as follows: 45 AF in January 2022 and up to 455 AF in February 2022.
- Arvin-Edison agrees to pay the Bureau for Transferred Water costs in the month following delivery of said water.
- Del Puerto will be responsible for conveyance from San Luis Reservoir to its Delta Mendota Canal turnouts.
- 5. Transferred Water is for use by Del Puerto and within the CVP place-of-use.

IN WITNESS WHEREOF, the parties, through their duly authorized representatives, have executed this agreement as of the day and year first above written.

Hello Gurwinder,

We will not be approving this request for the following reasons:

- \* Your property is actively farmed, and presumably utilizing only groundwater. Because of the Sustainable Groundwater Management Act and the resultant need for the District to support administrative actions that promote conjunctive use of both surface supplies and groundwater supplies, we want to encourage Landowners to develop their private delivery systems. Your proposal works contrary to that objective.
- \* The District does not have any policies which support the transfer of water between non-related entities, nor support profiteering on water supplies.
- \* Currently, the forecast does not support a prediction that there will be any CVP water allocation for 2022-23.
- \* For customers who do not wish to utilize their NVRRWP supply, there exists a turnback option which you are free to utilize, although again please note that the District does not intend to offer this option as an ongoing groundwater substitution program. I have attached this form and an explanation memo. Because we do not predict a CVP allocation, I suggest you indicate on the form that you want to retain at least 3AF for your use, at a minimum.

Like all Landowners within the District with active farming operations, you will be obligated to pay your per-acre assessments, and the fees for compliance with the Long Term Irrigated Lands Program (Watershed Coalition) and compliance with the Sustainable Groundwater management Act (SGMA).

Just as a side note, I would highly recommend that you consider the option of securing all of your water supply for your orchard. If you do not, and If you lose production in your well, there may be a chance the District will not have supplies readily available to provide this summer. And, given the ongoing drought circumstances, pre-planning for the next year is normally something that most of our orchardists do. Just my thoughts.

If you would like to return your NVRRWP supply, please return the attached form by COB Monday. Alternately, payment would be due by COB Monday if not.
