Project Operations


- Decreasing delta inflow limited Jones pumping to about 35% of capacity during November. Pumping dropped to its minimum level of 800 cfs today with no increase expected until the next significant storm arrives. Without export increases during December, pumping will fall significantly below Reclamation's most recent 90% exceedance forecast.
- SWP export during November averaged at about 25% of capacity. Pumping increased slightly early this month as the Projects shared available delta inflow under the Coordinated Operations Agreement.
- Sac Valley precipitation during November was only half of the monthly average.
 Accumulated precipitation for the season is about 35% of average. However, given that most of the seasonal precipitation typically occurs during the next 4 months, recovering from the current precipitation deficit remains a hopeful possibility
- The current storage in Shasta is about 2 MAF and dropping at about 2 TAF per day. Releases have declined to 3,500 cfs in efforts to conserve storage. Reclamation's latest conservative forecast shows Shasta beginning to refill later this month peaking at about 2.8 MAF by late March.
- Folsom storage dropped about 30 TAF during November bringing the current storage to 320 TAF. Releases have ramped down to 1,500 cfs as the need for fall salmon attraction and spawning flows decline. Under dry conditions, the reservoir will refill to only 65% of capacity; thus, limiting summer releases needed to support CVP allocations. Folsom is expected to refill by late May under median conditions.
- CVP demands were about 88 TAF during November; about 10% above the 15-year average.


2021 San Luis Operations

Under average hydrologic conditions, CVP San Luis would have filled by about 125 TAF during November. But persistent dry conditions quashed refill efforts and held storage flat at about 380 TAF throughout the month. As such, refilling CVP San Luis is no longer expected without above average precipitation occurring before April.

As shown on the attached San Luis storage projection graphs, under dry conditions, the reservoir will refill to about 65% of capacity by late January and storage will remain flat

through March. With average hydrology and minimal export cuts for fish protections, CVP San Luis is now projected to reach its peak storage by late March and will fall short of filling by about 100 TAF.
