RE: Activity Agreements – Staff Report for November, 2022

This memorandum serves as the Staff Report for November 2022 regarding specified<sup>1</sup> Water Authority activities not separately addressed on the Board meeting agenda.

#### 1. Integrated Regional Water Management (IRWM) Activity Summary

#### General Westside-San Joaquin Integrated Regional Water Management Plan (IRWMP)

DWR approved an amendment to the Proposition 1 Round 1 IRWM Grant administered through SLDMWA. In addition to granting a six-month work extension to July 31, 2024, the amendment reduces the number of wells required for the Broadview Aquifer Storage and Recovery Project. Since the estimate to complete the project was made in the fall of 2019 when the grant application was submitted, actual construction costs have increased more than 600%.

DWR announced its funding recommendations for the Proposition 1 Round 2 IRWM Grant Program. In the Westside San Joaquin Region, Del Puerto Water District (DPWD) will receive \$955,000 to fund development of a Decision Support Tool that will be used to site dams for flood control and water storage projects. The DPWD project was funded for the San Joaquin River Funding Area, one of two funding areas in the Westside San Joaquin (WSJ) IRWM Region. In the Tulare-Kern Funding Area, the Subsidence Prevention and Drought Resiliency Storage Project submitted by Westlands Water District was not selected for funding in DWR's draft recommendations.

#### 2. <u>Sustainable Groundwater Management Activity (SGMA) Activity Summary</u>

#### **Coordinated Activities**

Groundwater Sustainability Agencies (GSAs) have agreed at the Coordinated level to increase the meeting frequency in anticipation of the required 2025 Groundwater Sustainability Plan (GSP) Updates. The Updates must be finalized in less than two years so they can be adopted by all 23

GSAs in the Subbasin, including local governments, prior to submitting in January 2025. Detailed work on the Updates must wait until DWR issues the final determinations on the Subbasin's six GSPs. DWR ruled them incomplete in January 2022, and amended Plans were resubmitted by the GSP groups in July. The final determinations aren't expected until the late in the first quarter of 2023. While waiting for DWR's decision, GSP groups will review the Coordination Agreement and may recommend changes to that document.

Data compilation is underway for the Water Year 2022 Annual Report. The report must be submitted to DWR by April 1, 2023.

#### **General SGMA Activities**

The Subbasin's GSP groups are finalizing a grant application for SGMA Implementation Round 2 grant funding. A total of \$20 million is being requested. Proposed activities include construction of groundwater recharge projects, canal lining projects, a water use efficiency and reclamation project, filling data gaps, and enhancing the Subbasin's monitoring capabilities including an expansion of an Interconnected Surface Water Monitoring Network that is being established with previously awarded SGMA Implementation Round 1 funds. The Round 2 application is due in mid-December. San Joaquin River Exchange Contractors Water Authority will serve as the lead applicant.

Work is underway for projects funded by the \$7.6-million-dollar SGMA Implementation grant awarded to the Subbasin. Grant-funded activities include water supply reliability and groundwater recharge projects, monitoring and data collection, and funding for the previously noted 2025 GSP updates. Del Puerto Water District served as the lead applicant on behalf of the Subbasin, and signed the grant agreement with DWR in October.

#### 3. Drainage Activity Summary

#### **Grassland Basin Drainage Management Steering Committee Activity Summary**

- Prepare for and lead GBD Steering Committee meeting on November 18.
- Prepare GBD Budget

Work was initiated to develop the FY 2023-2024 GBD Activity Agreement budget.

Regional Board Grassland Bypass Project Stakeholder Meeting

A Regional Board meeting is scheduled for January 2023. Prepared preliminary information for presentation at the meeting.

- Mitigation Subcommittee. Organized and led the November mitigation subcommittee meeting.
- Legal Issues

Ongoing support is provided to support the legal issues that the Authority is involved in.

Mud Slough Restoration Project

The Water Authority adopted the CEQA for the project in December 2021. There were comments received on the project from the State Board, California Department of Fish and Wildlife (CDFW) and a group of commenters led by the Planning and Conservation League (PCL) A meeting is being scheduled with CDFW to review and move the project forward.

A total of 10 observation wells are planned to be installed to monitor groundwater levels and quality within the San Joaquin River Improvement Project and in a portion of Grassland Water District to the north. Work continues on permitting issues from Merced County and landowner issues.

- The SJRIP biological monitoring report was completed and submitted to regulatory parties.
- Compliance Monitoring

Work is continuing to comply with the monitoring requirement of the 2019 Revised WDRs and with the December 2019 Use Agreement. This monitoring includes particulate sediment and fish collection and analysis to continue to analyze possible impacts of very infrequent discharge from the Grassland Bypass Project to Mud Slough and the San Joaquin River. Work was completed to develop the program for 2023.

Grassland Drainage Area Coalition

Work continues to provide coverage for farmers within the Grassland Drainage Area for the Irrigated Lands Regulatory Program. Reporting forms are being prepared to send to farmers in late 2022 for reporting 2022 nitrogen application.

 Work is ongoing to support the Prop 84 Grant administered by Panoche Drainage District for improvements to the San Joaquin River Improvement Project.

#### San Joaquin Valley Drainage Authority Activity Summary

- Development of FY 23-24 SJVDA Budget including consultant scopes of work. Work is underway to develop the FY 23-24 SJVDA Activity Agreement budgets.
  - Participated in quarterly call with the Regional Board on the Irrigated Lands program compliance.
  - Prepare and lead San Joaquin Valley Drainage Authority Board meeting on November 1, 2022.

Topics included development of plan to comply with CVSALTS Nitrate Control Program through a management zone. Research of various means to comply are being researched. A meeting is being coordinated with the Delta-Mendota Subbasin Coordination Committee to investigate overlap of services.

Westside San Joaquin River Watershed Coalition

Work continues to provide coverage for farmers within the Grassland Drainage Area for the Irrigated Lands Regulatory Program. The work includes managing the monitoring program, assisting farmers with the necessary reporting to comply with the program and preparing reports for the Regional Board. Reporting forms are being prepared to send to growers for reporting 2022 nitrogen application. Development of monitoring program for 2023.

• Groundwater Protection Formula, Values and Targets

Coalitions are developing a methodology to establish nitrogen loading values and targets as required by the WDRs. Ongoing work includes meeting with other coalitions and staff developing the values and targets along with supporting that work through the SJVDA budget.

Management Zones

The Central Valley Basin Plan's Nitrate Permitting Strategy divided the Central Valley into Priority 1, Priority 2 and non-Prioritized basins. The Westside Coalition is in Priority 2. Priority 1 basins have developed and begun to implement their nitrate programs. The Regional Board is expected to issue notices to comply to Priority 2 basins in early 2023. The Westside San

Joaquin River Watershed Coalition is in a Priority 2 basin and therefore is expected to receive a Notice to Comply from the Regional Board in 2023. The Westside Coalition is working to develop a plan to help form a Management Zone to comply with the requirements. The Management Zone will incorporate all dischargers of nitrate to groundwater, including municipal wastewater plants, dairies and industrial dischargers. The Management Zone will need to identify domestic wells that are high in nitrate and develop and plan to provide alternative water. This added program will significantly increase the SJVDA budget to support this work and is being supported through the SJVDA budget. Coordinated follow up meeting with GSA coordinating committee.

#### Salt Control Program

Phase I of the Salt Control Program involves the development of a Prioritization and Optimization Study (P&O Study). Currently, consultants are compiling data in order to characterize current salinity conditions of both surface and groundwater across the Central Valley. Phase I of the Salt Control Program is expected to last years. This work is being supported through the SJVDA budget.

• Prop 84 Real Time Program Grant

Work continues on upgrading various monitoring stations and gathering monitoring data. Remaining work includes maintaining the stations and modeling to determine and manage salt discharges to the San Joaquin River.



#### 1. Call to Order/Roll Call

Vice Chair John Wiersma/SJREC called the meeting to order at 9:32 AM.

2. Committees to Consider Corrections or Additions to the Agenda of Items, as authorized by Government Code Section 54950, et seq

John Brodie/SLDMWA noted that the budget to actual report provided to the in-person attendees (Item 4b of the meeting agenda) is through August 2022, which is an update to the report through July 2022 included in the electronically transmitted meeting packet.

#### 3. Opportunity for Public Comment

No public comment was shared.

- 4. Committee to Review and Take Action on Consent Calendar
  - a) Minutes of the August 8, 2022 Regular Meeting
  - b) Budget to Actual Report (through August 2022)
  - c) Grant Reimbursement Summary Report

The Committee considered approval of the prior meeting minutes as presented in the meeting packet. The Committee also discussed the Budget to Actual Report through August 2022, and raised a question regarding the conclusion date of March 31, 2022 for one line item. Scott Petersen/SLDMWA offered to investigate this item, and provide the results to the Committee members. Augie Ramirez/Fresno County provided the motion to approve the Consent Calendar and Chase Hurley/Pacheco-Central Delta-Mendota seconded. The Committee voted by roll call; the motion was passed unanimously by those present.

5. Committee to Consider Approval of Special Projects Agreement for the SGMA Round 1 Grant Administration Expenses, Brodie

John Brodie referenced the Special Projects Agreement summary memo included in the meeting packet that provides the background and issue for decision. Ric Ortega/Grassland WD provided the motion for approval of the Special Projects Agreement, with Woodard & Curran providing grant administration services, and Vince Lucchesi/PID-Northern Delta-Mendota seconded. The Committee voted by roll call; the motion was passed unanimously by those present.

6. Committee to Consider Authorization of a Special Dues for SGMA Round I Grant Administration Expense, Brodie/Tarka

John Brodie referenced the Special Dues Assessment summary memo included in the meeting packet that provides the background and issue for decision. Ric Ortega provided the motion to authorize the Special Dues Assessment and Augie Ramirez seconded. The Committee voted by roll call; the motion was passed unanimously by those present.

7. Committee to Consider Authorization of an Application for SGMA Round 2 Grant Funding and Naming a Contractor/Consultant to Perform Grant Application and Submittal Tasks,
Brodie

John Brodie reminded members that DWR opened the SGMA Round 2 grant application on October 3, 2022. Grant applications are due to DWR by November 30, 2022. The SGMA Round 2 funding totals \$230 million, and includes specified priorities for funding awards. The Committee conceptually discussed the potential needs for additional funding to implement projects and management actions, as well as to fill data gaps identified in the Subbasin GSPs. Committee members were requested to submit potential projects and data gap needs to John Brodie by October 14, 2022. Given the schedule set by DWR, it is likely that the Committee will need to schedule a Special Meeting in the near future to select a lead applicant and determine the list of activities to include in the grant application. Joe Hopkins/Aliso WD provided the motion to proceed with preparation of a Round 2 grant application, and Augie Ramirez seconded. The Committee voted by roll call; the motion was passed by a majority of those present. Vince Lucchesi and Chase Hurley abstained because the Northern & Central Delta-Mendota Management Committees had not provided direction on this topic at their prior meeting.



8. Committee to Authorize a Cost-Share Percentage and Special Projects Agreement for SGMA Round 2 Grant Application Preparation and Submittal Tasks, Brodie

The Committee discussed splitting the costs of grant application preparation equally among the GSP groups. If a grant is awarded to the Subbasin, the cost share will be based upon participating entities and funded projects. Ric Ortega provided the motion to proceed with the proposed cost-share allocation based upon total project value for each GSA for the preparation of the grant application, and Jim Stilwell/Farmers WD seconded. The Committee voted by roll call; the motion was passed by a majority of those present. Vince Lucchesi and Chase Hurley abstained because the Northern & Central Delta-Mendota Management Committees had not provided direction on this topic at their prior meeting.

9. Committee to Consider Authorization of a One-Time Additional Dues Assessment for Legal and Technical Services Associated with GSP Revisions, Brodie

Anthea Hansen announced that the SGMA Round 1 Grant Agreement between DWR and Del Puerto Water District was executed on October 7, 2022; after the Coordination Committee meeting materials had been issued. John Brodie reviewed the key points in the summary memo included in the meeting packet. The Committee discussed the method that the Northern & Central Management committees had agreed upon regarding the additional dues, and also noted that the allocation would be consistent with the existing Coordination Agreement. Joe Hopkins provided the motion to proceed with authorization of a one-time assessment of additional dues, and Augie Ramirez seconded. The Committee voted by roll call; the motion was passed unanimously by those present.

- Committee to Discuss Process and Timeline for 2025 GSP Updates, Martin/Hopkins/Au Ramirez/Brodie
  - a) Common Chapter (including SMC and Tables)
  - b) Coordination Agreement

John Brodie reported that as directed by the Committee in its previous meeting, he met with Joe Hopkins and Augie Ramirez to develop a draft timeline for preparation of the 2025 GSP Updates. He referred the Committee members to the draft timeline included in the meeting packet. A list of required contents in the GSP Updates is also included in the meeting packet. DWR has not yet provided a response on the Amended GSPs submitted in July 2022. There are some critical path items, and decisions regarding which tasks the GSAs can perform, and which tasks will require consultants to perform. Leslie Dumas reminded the Committee that based upon the timeline, the end date for the water budgets is likely to be September 2023, with WY2024 presented as a projection. Leslie Dumas reminded the Committee needs to decide whether the USGS/USBR model or a spreadsheet-based approach will be used for the Subbasin water budget analyses. John Brodie emphasized that due to the member County approval processes, the draft 2025 GSP Updates must be issued by October 2024.

In addition to technical issues, the Committee also considered some policy issues and identified the need to revise and update the Coordination Agreement. Example language regarding dispute resolution will be circulated. Similarly, estimated budgets and projected finances need to be identified and considered. In addition to the Subbasin Technical Working Group, a Subbasin Finance Committee may be appropriate. The Committee also discussed the potential need to update the Data Management System (DMS), and to continue stakeholder outreach and engagement activities as part of the GSP Update process.

#### 11. Committee to Discuss Potential Additional Funding Opportunities, Brodie

John Brodie referred the Committee members to the list of potential funding opportunities included in the meeting packet, and offered to respond to member requests for additional information on the funding opportunities.

# 12. Committee to Discuss Merced County Well Ordinance and Executive Order N-7-22 and the Role of GSAs in Well Permitting, McBride/Ad. Ramirez/Brodie

Although a Merced County representative was not in attendance, John Brodie summarized the revised Merced County process for incorporating GSA input regarding installation of new groundwater supply wells, in accordance with the Executive Order. He noted that Merced County requested assistance in updating contact information for the Subbasin GSAs to be used for this purpose of soliciting input on new groundwater supply wells.

#### 13. Committee to Discuss Revised GSP/Common Chapter Implementation Changes, Brodie

John Brodie noted the tables included in the meeting packet prepared to identify and track the list of GSP implementation tasks for the Northern & Central regions.

#### 14. Committee to Discuss WY2022 Annual Report, Dumas/Brodie

Leslie Dumas/Woodard & Curran stated that a kickoff meeting had been held the preceding week with Provost & Pritchard for the WY 2022 Annual Report.
